Watershed

Management Plan: TRC report reviewed from March 11, 2024. There were 11 swales and drains

tested for phosphorus and nitrogen. James Tracey to review the data.

Phosphorus Quantity & Quality reaching Lake threshold. 56% of concentration

from Utley Hill. The highest phosphorus concentration comes from Erdoni Rd. Dike and Woodland Terrace. Highest Bacterial / E.coli & Nitrogen & Chloroform

Woodland Terrace and #2 Erdoni.

It was reported by Mary Roickle that 12 goose eggs were addled. The location of the nest was in close proximity of the dam. No report of the Electro fishing results.

Dam Emergency Plan: Gate Repair: Mark Walters reported that Cost estimates on components and

installation are in process.

Budget Review: None

Open Business: Boat Launch West side area. A proposal was received by Mark Walters with an

estimate of \$6500.00.
