1. **Bacteria Assessment:** proposal to assess the risks of the discharge coming from the two drains identified to have increased e-coli and coliforms.
2. **Phosphorous Load Inputing to the Lake at Utley Pond/Stream:** proposal to investigate Utley Pond & Stream Inlet in order to isolate potential sources of phosphorus that are discharging to that stream system and potential solutions.
3. **Removing Phosphorous From the Lake:** Years ago it was suggested by our previous lake consultant to place a pipe at the deeper level of water from our dam to siphon water nearest the lake bottom. Is this a viable and economical method to reduce the phosphorous load? If so what would you propose and what are the associated costs?
